

**Declaring Single Calculated and Responsive Bid and Recommending Approval**

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, during the bid opening on **NOVEMBER 13, 2019, B & J COMPUTERS AND ELECTRONICS SERVICES** drop its bid proposal for the said procurement;

WHEREAS, after the opening of bids, the bid proposal of the said bidder was found to be substantially complying;

WHEREAS, in the detailed evaluation of bids, **B & J COMPUTERS AND ELECTRONICS SERVICES** was declared as the Single Calculated Bid as Read for item no. 2 in the amount of **P 4,032.00**, while item no. 1 is a failure of bidding and was recommended Negotiated Mode of Procurement, subject for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **B & J COMPUTERS AND ELECTRONIC SERVICES** met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **B & J COMPUTERS AND ELECTRONIC SERVICES** the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;

**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **B & J COMPUTERS AND ELECTRONIC SERVICES** as the **SINGLE CALCULATED and RESPONSIVE BID** for item no. 2 for the *Procurement of UPS, 650VA Full AVR, Surge Protector with Replaceable Battery*; while **item no. 1 is for Negotiated Mode of Procurement**; under Project Reference No. – **PHO - 19 – 131 - rebidding**;
- b) To recommend award to **B & J COMPUTERS AND ELECTRONICS SERVICES** in the contract amount of **FOUR THOUSAND THIRTY TWO PESOS ONLY (P 4,032.00)**;
- c) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
