

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

## RESOLUTION NO. 20-0914 Series of 2020

WHEREAS, the <u>BOHOL DISTRICT JAIL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0867</u>; re; <u>Procurement of Service Vehicle as Prisoner's Van for the use of Bohol District Jail, Tagbilaran City, Bohol.</u> with an ABC of <u>P 118,180.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>GJ CAR CARE AND PARTS</u> <u>CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>GJ CAR CARE AND PARTS CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>GJ CAR CARE AND PARTS CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare GJ CAR CARE AND PARTS CENTER as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0682;
- b.) To recommend award to GJ CAR CARE AND PARTS CENTER for the delivery of goods/services under Negotiated Canvass No. 2020-0682 in the amount of P 118,084.50;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
