**WHEREAS**, the **PROVINCIAL LEGAL OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0878; re: Procurement of Vehicle Labor and Spare Parts for the Service Vehicle Mitsubishi Fuzion assigned under the Provincial Legal Office, New Capitol Compound, Tagbilaran City. with an ABC of P 244,365.00;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


