## RESOLUTION NO. 20-0961 Series of 2020

WHEREAS, the <u>PROVINCIAL LEGAL OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0878</u>; re; <u>Procurement of Vehicle Labor and Spare Parts for the Service Vehicle Mitsubishi Fuzion assigned under the Provincial Legal Office, New Capitol Compound, Tagbilaran City. with an ABC of <u>P 244,365.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
