**WHEREAS, the CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 221 re: PROCUREMENT OF VARIOUS OFFICE SUPPLIES with an ABC of P 138,033.08.**



- b.) To recommend award to ST. JUDE PRESS MARKETING AND SUPPLIES, for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 164, in the amount of **ONE HUNDRED THIRTY SEVEN THOUSAND THREE HUNDRED NINETY FOUR PESOS ONLY P 137,394.00**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


