BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 26-0917 Series of 2020

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0875; re; Procurement of Engine Oil, Chamois, Coolant, WD-40 and Vehicle Spare Parts for the Service Vehicles, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 60,730.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>GJ CAR CARE AND PARTS</u> <u>CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **GJ CAR CARE AND PARTS CENTER** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **GJ CAR CARE AND PARTS CENTER** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare GJ CAR CARE AND PARTS CENTER as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0690;
- b.) To recommend award to GJ CAR CARE AND PARTS CENTER for the delivery of goods/services under Negotiated Canvass No. 2020-0690 in the amount of P 60,607.50;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
