BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL PLANNING AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0734 re: Procurement of Office Supplies, Ink Toner, Isopropyl Alcohol and Flash Drives for the use at the Provincial Planning and Development Office, New Capitol Compound, Tagbilaran City. with an ABC of P 103,192.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE PRESS</u> <u>MARKETING AND SUPPLIES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>ST. JUDE PRESS MARKETING AND SUPPLIES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>ST. JUDE PRESS MARKETING AND SUPPLIES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
