WHEREAS, the **PROVINCIAL PLANNING AND DEVELOPMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. 2020-0734 re: Procurement of Office Supplies, Ink Toner, Isopropyl Alcohol and Flash Drives for the use at the Provincial Planning and Development Office, New Capitol Compound, Tagbilaran City, with an ABC of P 103,192.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ST. JUDE PRESS MARKETING AND SUPPLIES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
