BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2020 – 361re: PROCUREMENT OF SPLIT TYPE AIRCONDITIONING UNIT FOR USE OF WATER BACTERIOLOGY LABORATORY with an ABC of P 90,000.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- b.) To recommend award to SAMMY'S AIRCONDITIONING & REF. SERVICES AND REPAIR SHOP, for the delivery of goods under Negotiated Canvass No. – PHO – 2020 - 278, in the amount of **EIGHTY NINE THOUSAND NINE HUNDRED FIFTY PESOS ONLY** P 89,950.00;
