



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE SP - BOARD MEMBER LUCILLE YAP LAGUNAY**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2020-0528**; re; **Procurement of Various Office Supplies, Sporting Goods, I.T Supplies & Janitorial Supplies for use at the Office of the SP - Board Member Lucille Yap Lagunay, New Capitol Compound, Tagbilaran City**, with an ABC of **P 134,462.88**;
