BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>20-10</u>29 Series of 2020

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0904; re; Procurement of Tires, Engine Oil & Various Spare Parts for Service Vehicles, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 309,354.30.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>GJ CAR CARE AND PARTS</u> <u>CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **GJ CAR CARE AND PARTS CENTER** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **GJ CAR CARE AND PARTS CENTER** has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare GJ CAR CARE AND PARTS CENTER as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0712;
- b.) To recommend award to <u>GJ CAR CARE AND PARTS CENTER</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0712</u> in the amount of <u>P 309,313.50</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOI the foregoing findings.
