



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE PROVINCIAL AGRICULTURIST** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2020-0904**; re; **Procurement of Tires, Engine Oil & Various Spare Parts for Service Vehicles**, by the Office of the Provincial Agriculturist, **New Capitol Compound, Tagbilaran City**, with an ABC of **P 309,354.30**.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GJ CAR CARE AND PARTS CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **GJ CAR CARE AND PARTS CENTER** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **GJ CAR CARE AND PARTS CENTER** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




