BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0816; re; Procurement of Brochure, Flyers Printing & Tarpaulin for Marketing Promotion & Advertisement of Bohol Biodiversity Complex for the use at the Provincial Economic Enterprise Management Office, New Capitol Compound, Tagbilaran City. with an ABC of P 97,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BLUE ARROW SIGNS & PRINTS INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
