WHEREAS, the BOHOL TOURISM OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0738; re; Procurement of Rental of Lights, Sounds, Monitoring Systems & Video Equipment Needed for the Philippines Travel Exchange (PHITEX) 2020, by the Bohol Tourism Office, New Capitol Compound, Tagbilaran City, Bohol, with an ABC of P 862,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PTM DISCO RECORD CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PTM DISCO RECORD CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid PTM DISCO RECORD CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

- a.) To declare PTM DISCO RECORD CENTER as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0562;
- b.) To recommend award to PTM DISCO RECORD CENTER for the delivery of goods/services under Negotiated Canvass No. 2020-0562 in the amount of P 761,000.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


