BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>2020-414</u> Series of 2020

WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 267</u> re: <u>PROCUREMENT OF VARIOUS OFFICE AND JANITORIAL SUPPLIES</u> with an ABC of <u>P 416,101.84</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL QUALITY CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL QUALITY CORPORATION</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>BOHOL QUALITY CORPORATION</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a.) To declare <u>BOHOL QUALITY CORPORATION</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for items no. 1, 2, 3, 4, 5, 6, 7, 8, 10, 11, 12, 13, 15, 18, 19, 20, 21, 22, 23, 25, 26, 27, 28, 29, 30, 31, 32, 33, 36, and 37 in the amount <u>P 231,730.35</u> while items no. 9, 14, 16, 17, 24, 34, and 35 having no quotations from the suppliers, are recommended for re-canvass, for the <u>DELIVERY OF GOODS/SERVICES</u> under <u>Negotiated Canvass No. PHO 2020 205;</u>
- b.) To recommend award to <u>BOHOL QUALITY CORPORATION</u> in the amount of <u>TWO HUNDRED THIRTY</u> <u>ONE THOUSAND SEVEN HUNDRED THIRTY PESOS AND 35/100 (P 231,730.35)</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2020 205</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
