BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST - AGRIBUSINESS of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0730; re; Procurement of Diesel Fuel for the Service Vehicles, by the Office of the Provincial Agriculturist Agribusinesss, New Capitol Compound, Tagbilaran City. with an ABC of P 275,780.60;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MPC offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
