



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL GENERAL SERVICES OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2020-0800**; re; **Procurement of Tires for the Service Vehicles Assigned at the Provincial General Services Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 212,100.00.**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


