WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0718; re; Procurement of Christmas Lightnings for the Bohol Provincial Capitol Building, by the Provincial General Services Office, Tagbilaran City.. with an ABC of P 427,325.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that D 18TH HI-WAY MARKETING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>D 18TH HI-WAY MARKETING</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid D 18TH HI-WAY MARKETING has been found to be ELIGIBLE and its bid, RESPONSIVE;
