WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0848; fe; Procurement of Tires for the Backhoe & Service Vehicles, by the Provincial Motor Pool Office, New Capitol Site, Tagbilaran City, with an ABC of P 214,248.00;
