**WHEREAS**, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. \_\_\_\_\_ series of 2018 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY** in undertaking Procurement Request under **PR No. – PHO – 2019 – 346** re: **PROCUREMENT OF DIESOLINE TO BE USED FOR THE PHO MAIN SERVICE VEHICLES** with an ABC of **P 651,038.22**;


**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL JL DISTRIBUTION SYSTEM, INC.**, offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

**WHEREAS**, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **BOHOL JL DISTRIBUTION SYSTEM, INC.**, has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b. To recommend award **BOHOL JL DISTRIBUTION SYSTEM, INC.**, for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2020 - 317**; in the amount of **SIX HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED NINE PESOS AND 85/100 P 649,809.85**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


