



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE GOVERNOR** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0876; re; Procurement of Engine Oil, Chamois, Coolant, WD-40 and Vehicle Spare Parts for the Service Vehicles, by the Office of the Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 102,456.00;


