WHEREAS, the OFFICE OF THE PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0735; re; Procurement of Cellophane Bag w/ Provincial Logo, Sando Bag and Straw Binder for the use at the Office of the Provincial Social Welfare and Development, Tagbilaran City, Bohol. with an ABC of P 175,360.00;






