BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 20-054A Series of 2020

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No.2020-0350; re; Procurement of Motorcycle for use at Project/Field Monitoring, by the Office of the Provincial Veterinarian, Tagbilaran City. with an ABC of P 180,000.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that VISMOTOR CORPORATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
