WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0350, re; Procurement of Motorcycle for use at Project/Field Monitoring, by the Office of the Provincial Veterinarian, Tagbilaran City. with an ABC of P 180,000.00.
