- b.) To recommend award to AMEE'S OFFICE AND SCHOOL SUPPLIES in the amount of **NINETY NINE THOUSAND EIGHT HUNDRED NINE PESOS ONLY (P 99,809.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 222;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings






