WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0850; re; Procurement of Vehicle Spare Parts for the Service Vehicles assigned under the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 84,120.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 200 M AUTO REPAIR SHOP & PARTS including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid 200 M AUTO REPAIR SHOP & PARTS has been found to be ELIGIBLE and its bid, RESPONSIVE;
