WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0907; re; Procurement of Oil Filter, Fuel Filter & Various Vehicle Oil, by the Provincial General Services Office, New Capitol Compound, Tagbilaran City. with an ABC of P 233,695.00;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
