

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 220</u>re: <u>PROCUREMENT OF VARIOUS JANITORIAL SUPPLIES, LED ENERGY SAVING BULB & 9v BATTERIES</u> with an ABC of P 197,603.08.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>DELMA</u> <u>ENTERPRISE</u>, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DELMA ENTERPRISE**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **DELMA ENTERPRISE**, has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>DELMA ENTERPRISE</u>, as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE</u> <u>QUOTATION</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under <u>Negotiated Canvass No. PHO 2020 163</u>;
- b.) To recommend award to <u>DELMA ENTERPRISE</u>, for the delivery of goods under <u>Negotiated</u> <u>Canvass No. PHO 2020 163</u>, in the amount of <u>ONE HUNDRED NINETY SIX THOUSAND TWO</u> <u>HUNDRED EIGHTY FIVE PESOS ONLY P 196,285.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
