BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF SP-BOARD MEMBER ROMULO G. CEPEDOZA of the PROVINCIAL GOVERNMEN OF BOHOL made procurement of goods under Purchase Requests No. 2020-0741 re; Procurement of various Office Supplies for the use at the Office of Board Member Romulo G. Cepedoza, New Capitol Building, Tagbilaran City, with an ABC of P 63,782.02;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>ST. JUDE PRESS MARKETING AND SUPPLIES offered</u> the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>ST. JUDE PRESS MARKETING AND SUPPLIES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>ST.
