WHEREAS, the PROVINCIAL MOTOR POOL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0572; re; Procurement of Tires for use at Provincial Motor Pool Office, New Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City. with an ABC of P 488,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of CARE AUTOHAUS including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid CARE AUTOHAUS has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;




