WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST/FISHERIES DIVISION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0307; re; Procurement of Hardware Materials, Water Dispenser and Solar Powered Oxygenator Water Oxygen for use at the Office of the Provincial Agriculturist/Fisheries Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P 79,400.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that D 18TH HI-WAY MARKETING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of D 18TH HI-WAY MARKETING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid D 18TH HI-WAY MARKETING has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
