BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST/FISHERIES DIVISION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0307; re; Procurement of Hardware Materials, Water Dispenser and Solar Powered Oxygenator Water Oxygen for use at the Office of the Provincial Agriculturist/Fisheries Division, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of P79,400.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>D 18TH HI-WAY MARKETING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>D 18TH HI-WAY MARKETING</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>D 18TH HI-WAY MARKETING</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>D 18TH HI-WAY MARKETING</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. <u>2020-0211</u> except <u>item nos.</u>**2** & 4;
- b.) To recommend award to <u>D 18TH HI-WAY MARKETING</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0211</u> in the amount of <u>P 58,241.00</u> except <u>item nos.2 & 4</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
