BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL INFORMATION & MEDIA RELATIONS</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0570</u>; re; <u>Procurement of Shotgun Condenser Microphone with Lyre & LED Light with V-Mount Battery for the use at Provincial Information & Media Relations, New Capitol Compound, <u>Tagbilaran City.</u> with an ABC of <u>P 232,280.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B & J COMPUTER</u> <u>SALES AND ELECTRONIC SERVICES INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
