WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0899; re; Procurement of Raincoat to be Distributed to the BALA Members, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 101,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LEZAR TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;




