WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020,0899; re; Procurement of Raincoat to be Distributed to the BALA Members, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 101,500.00;
