WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-214 (re: Procurement of Novel Coronavirus (2019-nCoV) Detection Kit, DNA/RNA Extraction Kit and VTM Nasopharyngeal and Oropharyngeal Swabs for use the COVID-19 PCR Laboratory, Bohol Provincial Health Office, Tagbilaran City, to address the Ongoing Threat of COVID-19, Provincial Health Office, New Capitol Compound, Tagbilaran City, with and ABC of P 10,020,000.00;
