**WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 269 re: PROVISION FOR YEAR 1 ISO 9001:2015 ACCREDITATION AUDIT (ON SITE) with an ABC of P 204,075.20.**


**WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TUV SUD PSB PHILIPPINES INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,**

**WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TUV SUD PSB PHILIPPINES INC., including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid TUV SUD PSB PHILIPPINES INC., has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;**


**NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:**


