WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 269</u>re: <u>PROVISION FOR</u> YEAR 1 ISO 9001:2015 ACCREDITATION AUDIT (ON SITE) with an ABC of P 204,075.20.
