WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0900; re; Procurement of BALA I.D. to be distributed to the BALA Members, by the Office of the Provincial Veterinarian, New Capitol Building, Tagbilaran City with an ABC of P 259,000.00;



WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of ADS & PRINTS REPUBLIQ including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid ADS & PRINTS REPUBLIQ has been found to be ELIGIBLE and its bid, RESPONSIVE;


