WHEREAS, the GOVERNOR'S OFFICE - CENTER FOR CULTURE & ARTS DEVELOPMENT of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0021; re; Procurement of Local Gift Boxes/Token, for the media practitioners and influencers from local, regional, national levels in innovating tourism promotions through DASIG-Bohol's Digital Streaming videos & omnichannel approach by the Center for Culture & Arts Development, New Capitol Compound, Tagbilaran City. with an ABC of P 160,000.00;
