WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. <u>20-1049</u> series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the <u>PROVINCIAL ENGINEER'S OFFICE</u> in undertaking Procurement Request under PR No. <u>2020-378</u> re: <u>Procurement Of Aggregate Subbase Course</u> (Anapog) For Use In The Maintenance Of Various Provincial Roads For Project Management Division(PMD) Iii-Set Lwith an ABC of <u>P 600,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BNYU</u> <u>DEVELOPMENT CORPORATION</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
