WHEREAS, the **PROVINCIAL TREASURY OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0773; re; Procurement of Dot Matrix Printer and Android TV for the use at the Provincial Treasury Office, New Capitol Building, Tagbilaran City, with an ABC of P 61,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:


