WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0884; re; Procurement of Beef Protein for the K9 Unit at the Tarsier 117 for the use of Provincial Disaster Risk Reduction Management Office, New Capitol Building, Tagbilaran City. with an ABC of P 77,280.00.
