WHEREAS, the PROVINCIAL INFORMATION & MEDIA RELATIONS of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0792, re; Procurement for the Rental of Online Telecast Live Broadcasting Equipment for Information Dissemination for CoVid19 Information Education Campaign, by the Provincial Information & Media Relations, New Capitol Compound, Tagbilaran City...with an ABC of P 134,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 136 ACTIVE EVENTS EQUIPMENT RENTALS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
