**WHEREAS**, upon the conduct of post qualification by the Technical Working Group, DEXTEL TRADING, met the required legal, technical and financial requirements for the said project;

**WHEREAS**, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by DEXTEL TRADING the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;


**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- c.) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




