

**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0732; re; Procurement of Vinegar Containers & Stand-Up Pouch, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City, with an ABC of P 150,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CSL AGRIVET SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






