

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. <u>2021</u> - 052 Series of 2021

WHEREAS, the <u>CENTER FOR DRUG EDUCATION AND COUNSELLING</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 026</u> re: <u>PROCUREMENT OF OFFICE SUPPLIES AND DEVICES</u> ABC of <u>P 121,456.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL
MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PARK AVENUE GENERAL MERCHANDISE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>PARK AVENUE GENERAL MERCHANDISE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PARK AVENUE GENERAL MERCHANDISE as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 120,946.20 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. PHO 2021 026;
- b.) To recommend award to PARK AVENUE GENERAL MERCHANDISE in the amount of ONE HUNDRED TWENTY THOUSAND NINE HUNDRED FORTY SIX PESOS AND 20/100 (P 120,946.20) for the delivery of goods under Negotiated Canvass No. PHO 2021 026;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
