


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to **PARK AVENUE GENERAL MERCHANDISE** in the amount of **ONE HUNDRED TWENTY THOUSAND NINE HUNDRED FORTY SIX PESOS AND 20/100 (P 120,946.20)** for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 026;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
