



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL TREASURY OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0063, re: Procurement of Diesel for use at the Provincial Treasury Office, New Capitol Compound, Tagbilaran City, with an ABC of P 103,999.50;
