## RESOLUTION NO. 2 - 0076 Series of 2021

WHEREAS, the <u>PROVINCIAL TREASURY OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0063</u>; re; <u>Procurement of Diesel for use at the Provincial Treasury Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 103,999.50</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL JL DISTRIBUTION</u> <u>SYSTEMS INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **BOHOL JL DISTRIBUTION SYSTEMS INC.** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **BOHOL JL DISTRIBUTION SYSTEMS INC.** has been found to be ELIGIBLE and its bid, RESPONSIVE;
